RAFTS, TUBES, AND OTHER PERSONAL WATERCRAFT AND FLOATATION DEVICES MAY BE CAPSIZED, CAUGHT ON BRANCHES AND ROCKS, PUNCTURED, AND/OR DIFFICULT TO MANUEVER. INFANTS, SMALL CHILDREN, INDIVIDUALS WHO CANNOT SWIM, AND ANYONE SUFFERING FROM SERIOUS MEDICAL CONDITIONS SHOULD NOT FLOAT THE RIVER. PERSONAL FLOATATION DEVICES SHOULD BE WORN BY ALL PERSONS WHILE ON THE WATER.**

**Statement of Charges:**

The undersigned, as lessee, hereby hires from Boise River Raft and Tube Rentals, as lessor, equipment with associated charges listed on the attached receipt. Equipment rented on the following terms and conditions:

A valid picture I.D. (Drivers License) is required to rent any equipment. **A VALID CREDIT CARD IS REQUIRED FOR RAFT, KAYAK, AND DELUXE TUBE RENTALS.** A \$20.00 refundable deposit or Credit Card deposit is required **per** vest and paddle. Lessor only accepts cash or credit cards. **NO PERSONAL CHECKS ACCEPTED.**

**Additional Charges:**

Equipment rental is for a period of three (3) hours and is due back today at \_\_\_\_\_ **Please Initial \_\_\_\_\_.** All equipment is to be returned at Ann Morrison Park. Equipment is **NOT** to be kept overnight. Lessee acknowledges and agrees to pay late fees of \$30/hour for rafts, kayaks and \$10/hour for Deluxe tubes, tubes, paddles, and vests, and agrees that these fees are per hour or any fraction thereof past the return time. Lessee acknowledges and agrees to pay a fee of \$150 per raft, kayak and \$50 per item for all other equipment kept overnight. Equipment can be returned at Ann Morison Park until 8:00 p.m. (Monday-Thursday) and 9:00 p.m. (Friday, Saturday, Sunday and Holidays). Equipment not returned by 11:00 a.m. the day after renting will be reported stolen.

Lessee acknowledges and agrees to be responsible for the cost of lost, stolen, or damaged equipment. If rental equipment is not returned in suitable condition, as determined by lessor, lessee understands and agrees that lessor reserves the right to charge lessee for any damages, repairs, replacement, or special cleaning of property. Lessee agrees and authorizes lessor to use lessee's security deposit and/or charge lessee's credit card on file for such costs. Replacement costs are:

6 man raft - \$2,850.00 4 man raft -\$2,300.00 Kayak - \$1,795.00 Kayak Paddle - \$65.00 Raft Paddle - \$25.00 Tube -\$350.00 PFD - \$25.00

Lessee agrees to notify lessor upon return of any damage sustained while the equipment was in lessee's possession. **Please Be Aware:** Do not leave rafts, kayaks or tubes in the sun – they may explode.

**Lessee Certifies** that he/she is at least 18 years old and acknowledges, agrees, and accepts that:

1. Per Idaho State Code and I.D.A.P.A Rule all persons 14 years of age and younger must wear a U.S. Coast Guard approved personal floatation device (PFD) while in or upon a boat or raft. Additionally the lessor requires that all persons using rental rafts or kayaks must have a PFD accessible while floating the river.
2. Rafts or kayak may not be used to carry people in excess of the carrying capacity.

**Express Assumption of Risk and Responsibility:**

Lessee understands and is aware that rafting, tubing, and floating the river are **Hazardous** activities. Lessee understands that use of lessor's tubes, rafts, kayaks and other equipment involves a risk of injury to any and all parts of the user's body and possible death. Lessee hereby agrees to freely and expressly assume and accept any and all risks in the use of the equipment rented.

Lessee agrees to expressly indemnify, defend, and hold Boise River Raft and Tube Rentals, its officers, agents, and employees harmless from and against, any and all liability, expense, loss, injury, or death to lessee, or any person or property, including reasonable attorney’s fees, in instituting or defending any action or proceeding arising from lessee’s rental of equipment, including, but not limited to, claims for negligence, breach of warranty, contract, claim, or any other legal theory. Lessor assumes no risk of injury to lessee, or any liability for the use of equipment.

Lessee acknowledges and agrees that all passengers 18 years of age and older who will be using equipment have signed the Passenger Release of Liability Agreement on back. Total persons using a tube, raft orkayak

All rafts, kayaks, tubes, and other equipment rented from Lessor are for use only on the Boise River between Barber and Ann Morrison Parks.

Lessee acknowledges that lessor is not the manufacturer or dealer of the equipment and has not made and does not make any representation, warranty, or covenant, express or implied, with respect to the condition, quality, durability, or suitability of the equipment.

This agreement combined with the Passenger Release of Liability Agreement constitutes the full agreement between lessor and lessee. There may be no modifications to this agreement. Lessee acknowledges he/she has received the equipment listed on the attached receipt and has inspected the equipment and finds that it is in good condition and suitable for lessee’s purposes.

Additionally, I, my children, and all other guests who have signed this agreement hereby certify no medical diagnosis of Coronavirus/COVID-19, or if a diagnosis has been received, certified medical clearance as non-contagious by state or local public health authorities. Additionally, to my knowledge, no signees of this agreement or minors in our party participating in floating the Boise River have not been exposed to someone with a suspected or confirmed case of the Coronavirus/COVID-19. I also hereby certify that I, my children, and all other guests who sign this agreement are following all CDC and Central District Health recommended guidelines to the best of our ability and limiting exposure to the Coronavirus/COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren), myself, and all other guests who sign this waiver of liability may be exposed to or infected by COVID-19 while renting equipment from Boise River Raft and Tube Rentals, while floating the Boise River, while returning said equipment at Ann Morrison Park, and while riding the shuttle, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren), myself, and all other guests who sign this waiver of liability as well as any minors participating in floating the Boise River in our party (including, but not limited to, personal injury, disability, and death) that may or may not be the result of illness from the Coronavirus/COVID-19. This includes all damages, loss, claim, liability, or expenses, of any kind, that I or my child(ren), other minors in our group, or any other guests who sign this waiver may experience or incur in connection with the activity of floating the Boise River. On my behalf, on behalf of my children and any other minor guests who float the Boise River in my party, my heirs or any personal representatives, and on behalf of all other guests who sign this agreement I hereby release, covenant not to sue, discharge, and hold harmless Zeller Recreation Incorporated, its DBA Boise River Raft and Tube Rentals, and its employees, agents, and representatives of and from any claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. Boise River Raft and Tube Rentals assumes no risk of injury to passengers, or any liability for the use of equipment.

Passenger acknowledges that Boise River Raft and Tube Rentals is not the manufacturer or dealer of the equipment and has not made and does not make any representation, warranty, or covenant, express or implied, with respect to the condition, quality, durability, or suitability of the equipment. Passenger acknowledges further that wearing a U.S. Coast Guard approved personal flotation device while in or upon a raft is a safety requirement, and that the U.S. Coast Guard and State of Idaho require that a suitable life vest be provided for each person in all boats- motorized & non-motorized. Passenger acknowledges that Boise River Raft and Tube Rentals has provided a sufficient number of life jackets at no extra charge at the time of rental. **I AM 18 OR ABOVE THE AGE OF 18 AND I HAVE READ THIS RELEASE OF LIABILITY INCUDING COVID-19 RELEASE OF LIABILITY OF PAGE 2 OF THIS AGREEMENT AND AGREE TO ALL TERMS AND CONDITIONS.**
