A valid picture I.D. (Drivers License) is required to rent any equipment. A VALID CREDIT CARD IS REQUIRED FOR RAFT, KAYAK, AND DELUXE SINGLE AND DOUBLE TUBE RENTALS. A \$20.00 refundable deposit or Credit Card deposit is required per vest and paddle. Lessor only accepts cash or credit cards. NO PERSONAL CHECKS ACCEPTED.

All equipment is to be returned at Ann Morrison Park. Equipment is **NOT** to be kept overnight. Lessee acknowledges and agrees to pay late fees of \$30/hour for rafts and kayaks; \$10/hour for deluxe single and double tubes; and \$10/hour for paddles and vest. Lessee agrees that these fees are per hour or any fraction thereof past the return time. Lessee acknowledges and agrees to pay a fee of \$150 per raft and/or kayak and \$50 per item for all other equipment kept overnight. Equipment can be returned at Ann Morison Park until 9:00 p.m. Equipment not returned by 11:00 a.m. the day after renting will be reported stolen.

Lessee acknowledges and agrees to be responsible for the cost of lost, stolen, or damaged equipment. If rental equipment is not returned in suitable condition, as determined by Lessor, Lessee understands and agrees that Lessor reserves the right to charge Lessee for any damages, repairs, replacement, or special cleaning of property. Lessee agrees and authorizes Lessor to use Lessee's security deposit and/or charge Lessee's credit card on file for such costs.

Lessor has implemented preventative measures to reduce the spread of illnesses but cannot guarantee that Lessee will not be exposed to or infected by diseases. Lessee acknowledges the risks, including potential illness or injury.

The Lessee grants the Lessor the right to take photographs, video recordings, or other media (the "Media") of the Lessee and any minors or guests in their group during activities. The Lessee further grants the irrevocable right to use, reproduce, publish, and distribute the Media for any lawful purpose, including promotional and commercial uses, without compensation. It is acknowledged that the Lessor is the exclusive owner of all rights, including copyright, to the Media. If photographs are taken they may be available for purchase through a third-party provider.

Lessee Certifies that he/she is at least 18 years old and acknowledges, agrees, and accepts that:
